



**Use of Building Performance Data
ASHRAE International Headquarters**

Terms and Conditions for Use

Performance data from building systems operating within ASHRAE International Headquarters are the exclusive property of ASHRAE and are subject to conditions for use as determined by ASHRAE. ASHRAE supports the use of such performance data to promote understanding of and advancement of building system technologies; however, ASHRAE retains ownership of all such data and control of its publication and use in derivative works.

An exception to this policy is access to and use of data related to performance of their respective equipment by manufacturers whose equipment is used in ASHRAE International Headquarters.

Another exception to this policy is for individuals that only wish to view and use the "as is" data for their own education or interest with no intention to distribute the data further.
